SUBJECT: Revocation of Temporary Authorization to Store and Process Brine and Other
Waste Substances Pursuant to R.C. 1509.22

Pursuant to Ohio Revised Code Section 1509.22, the Chief of the Division of Oil and Gas Resources Management (“Chief” or “Division”) issues the following Order:

BACKGROUND:

- (1) On April 9, 2014, ATP Unlimited, LLC (“ATP Unlimited”) submitted to the Division an application pursuant to R.C. 1509.22(B)(2)(a), proposing to operate a truck and vessel washing facility to be located at 48059 Outpost Road, Caldwell, Ohio in Noble County (“ATP Unlimited Truck Washing Facility”). On June 20, 2014, the Division issued to ATP Unlimited Chief’s Order No. 2014-182, which provided temporary authorization to store and process brine and other waste substances at the ATP Unlimited Truck Washing Facility.
- (2) On February 26, 2015, ATP Unlimited informed the Division by electronic mail message that it was no longer planning to operate the ATP Unlimited Truck Washing Facility pursuant to Chief’s Order No. 2014-182.

ORDER:

Chief's Order No. 2014-182 is revoked.
